**New to Jefferson County, Oregon?** The following information will help you get hooked up!

**Phone:** Jefferson County gets phone service from Century Link. The Company's customer Service number is 877.720.3428. You also have many other choices for telephone service.

**Garbage:** Madras Sanitary picks up at many county & city residences. Their number is 475-2071. They also operate a free recycling facility at their business location, 1778 NW Mill St., in the city-county Industrial Park north of Madras. Residents can haul their own refuse, lawn clippings and recyclables to the Box Canyon Transfer Station, located off Grizzly Road east of Madras, which can be reached at 475-1983. Charges are based on weight.

**Electricity:** Pacific Power is the primary supplier of electricity for citizens in Jefferson County. Their customer service number is 1-888-221-7070. Central Electric Co-Op also provides service to the rural areas in Jefferson County and can be reached at: 541-548-449, 548.2144, or 475-3266.

**Gas:** Hookups are available through Cascade Natural Gas 1-888-522-1130.

**Sewer:** Service is provided at the city level. The respective numbers are: Madras 541-475-2344, Culver 541-546-6494, and Metolius, 541-546-5533.

**Water:** Deschutes Valley Water District is the primary water supplier in Jefferson County. They have been recognized as having the best-tasting domestic water in the state & country. DVWD can be reached at 475-3849. The City of Madras contracts with DVWD to provide water service to city residents. For water hookups inside the city limits call 475-2344.

**Television:** Cable service is provided for much of the County by Crestview Cable. Their office is at 374 SW 5th St., #A, and can be reached at 541-475-2969. There are several other companies serving this area with television service. Check the phone book or the web.

**Internet Provider:** Madras.Net at 541-508-2498, is a county based provider, as is Crestview Cable at 541-475-2969. There are several other services available in this area for internet service. Check in the phone book, or on the web.
